

INFORMATION SHEET FOR VENDORS **PLANT SALE – MAY 14, 2017**

When: May 14, 2017, 9 a.m. to 1 p.m.

Where: On the Central Experimental Farm, in the parking lot beside the Neatby Building, 960 Carling Avenue at Maple Drive, just east of the Civic Hospital. Coming from the Prince of Wales round-about, drive west on the Driveway, turn right at Maple Drive; or alternatively, take Carling Avenue, going east or west, to Maple Drive and the lot is right there. Watch for signs.

Where do I park: No vehicles are allowed on the lot after 8:15am. Set up will start at 6:45 am. There will be parking attendants on site to direct you to a parking area nearest to your allotted spot(s).

Merchandise: As this is a plant sale, we ask that a minimum of 80% of the items for sale be plant material. The remaining 20% can be plant and garden related items.

Display Space: A single space is equal to two regular parking spaces, approx. 17 ft wide x 20 ft deep. Please note that your display cannot encroach upon or disturb your “neighbour”.

Set up: Set up time is from 6:45am to 8:15 a.m. the morning of the sale. For the safety of everyone, we ask that if you are unloading a vehicle that you do this one vehicle at a time. All vehicles to be removed from the lot before 8:15 a.m.

Weather protection: The sale is held outdoors, rain or shine. Vendors are encouraged to provide their own protection against inclement weather. As the parking lot is now paved, any shelter must be free-standing without the use of in-ground pegs and/or guy wires.

What if I Cancel? If you cancel more than 21 days prior to the event, you will receive 100% refund of your registration fee. If cancellation is between 14 to 20 days prior to the day of the sale, you will receive a 50% refund. For cancellations less than 14 days prior to the day of the sale, there will be no refund. Cancellation notices must be in writing.

Clean-up: Vendors must occupy their spot(s) for the entire sale from 9 a.m. to 1 p.m. Spots are not to be cleared before the sale has ended. Please leave your area as you found it.

Washrooms: A portable toilet will be available on site.

How do I register? You must complete the Plant Sale Registration Form attached, and mail it with your payment to: **Friends of the Farm, Building #72, Arboretum, Experimental Farm, Ottawa, ON, K1A 0C6.** Please **post-date** cheque for April 1, 2017, made payable to: **Friends of the Farm.**

PARTICIPANT AGREEMENT

1. I waive all liability on the part of the Friends of the Central Experimental Farm (FCEF) and Agriculture Agri Food Canada (AAFC) for damages or loss of my property on the Central Experimental Farm (CEF) by theft, fire or other causes during the FCEF Plant Sale on May 14, 2017. I understand and agree that neither the Experimental Farm, AAFC, nor FCEF will cover any loss or theft with insurance and that I am solely liable for the property while it is located on the CEF. For the purposes of liability, the property is deemed to be in my possession while on the CEF. This is binding on my heirs and assigns.
2. I agree that a minimum of 80% of the goods for sale will be plant material.
3. REGISTRATION FEE - I agree to pay \$80.00 per spot in full, at the time of submitting my registration form. Please **post-date** cheque for April 1, 2017, made payable to: **Friends of the Farm.**
4. I understand that if I cancel more than 21 days prior to the event, I will receive 100% refund of the registration fee. If I cancel between 14 to 20 days prior to the day of the sale, I will receive a 50% refund. For cancellations less than 14 days prior to the day of the sale, there will be no refund. Cancellation notices must be in writing.
5. I give permission for my name, phone number, email and social media information to be used in any promotional material. I agree to supply the FCEF with on-line photos for marketing purposes.
