TREASURER'S REPORT/FINANCIAL ISSUES - Randy

- Randy presented the December 2021 financial statement. Membership fees, book sales, card sales, fund raising, donations and interest on investments are all higher than 2020. The bottom line is a \$31,237 surplus in 2021, whereas we had a loss in 2020.
