- The CEF Management Plan is being reviewed and the CEF Advisory Council met to discuss.

PROJECTS UPDATE

- Bench Project: -Project has been completed. Maintenance to continue.
- Building Book: Nothing to report.
- **Garden tours:** Need a coordinator for the tours. Donna reported 14 volunteers interested in leading tours.
- Donor Tree Program: The Friends have begun working with AAFC on a proposal for a new donor tree program. Part of the discussion has been how to label the trees, noting the pros and cons of each type. Need a leader and team for this program.
- Woodland improvement: Invasive plants were removed; more planting might take place this fall.
- The Tree book:- Projected date for the publication is Spring 2024.
- Master Gardener lectures: Lectures complete for 2022. Lectures are planned to be given in ZOOM in 2023 to accommodate a larger number of attendees.
- Greeting Cards: Selling steadily but slowly.

- Creation of pathways: Blaine reported that AAFC staff were not prepared to move forward with this project at this time.
- **Upgrading of the arches:** Blaine reported that due to other priorities in the Ornamental Gardens, this project be placed on the back burner for the time being. Fiona Cowell is to identify which roses have been lost and need to be replaced.
