PROJECTS UPDATE

- **Bench Project:** -Deborah will clarify the status of the bench project and coordination in respect of finishing up the paper work and responding to emails, and ongoing maintenance.
- **Garden tours:** Need to clarify if we have a coordinator for the tours. Donna reported 14 volunteers interested in leading tours. Question of donations versus small registration fee discussed. Form to be drawn up to ensure all info is shared.
- **Donor Tree Program:** Meeting to discuss this program proposal will be held on October 20, 2022.

- Woodland improvement: on-going work
- **The Tree book:** In the process of selecting trees to be included; a schedule and budget info is required.
- **Greeting Cards:** Selling steadily but slowly. Dell to ask Richard for two photos for postcards which will be included with membership renewals and have them printed.
- **Creation of pathways:** Long term project, need a design, possibility of grants, suggestions from interested groups.
- **Upgrading of the arches:** It is proposed that AAFC will design the arches and the Friends will pay for the wood for the arches and the required fence. AAFC will build the arches over the winter. Budget info needed.
