## TREASURER'S REPORT:

- FCEF is still in a strong position although in a deficit for 2023. Donations are expected to increase later in the year due to Non-Dinner campaign and the CelebriTree project.

#### PROJECTS UPDATE:

• Garden tours - Linda

Tours for 2024 will be planned in February or March. More tour leaders are needed. Linda will meet with Tourism Ottawa in the spring. The Board also discussed other opportunities for involving more people in our teams, including a team to track the bloom times is needed for the arboretum.

• Tree Donor Program — Elizabeth

The website was in place for the launch on Sept 12. Twenty-eight people have responded so far for the sixteen trees, and have been matched with choice of tree on a first-come first-served basis. Once notified by the CelebriTree team, those satisfied with the choice of tree and location will have three days to pay.

• Improvement of the Woodland — Eric

A few small trees have been planted. The team is trying to get rid of the buckhorn, and is looking to AgCan staff for suggestions for ground cover as a pilot project to combat invasive plants in selected sites (not necessarily in the woodland).

• Tree Book — Eric

A search is underway for grants and a publisher.
